'Like All These Country Folks Very Stupid': Glasgow Highlanders in the Poor Law Application Records

What the records contain

The majority of poor relief application forms as filled in by the city's inspectors are of tremendous value to family historians. However, the date and place of birth were not the only things that interested them. To complete the application form, they would also need to find out

- each address at which the applicant had lived, for as far back as they could recall, and for how long
- their occupation, earnings and rent paid
- names of parents, spouse, siblings, children, in-laws, and grandchildren, their addresses and income
- the reason for the application
- religious denomination
- date and place of marriage
- state of health
- details of any family problems that had led to their present circumstances, such as abandonment or bereavement.

The majority of original poor law records for this time period are held by local archives throughout Scotland. Some indexes to these are available online and can help you determine if there is material relevant to your research housed in a particular archive. A selection of these is listed below.

Online Collections

Aberdeen City and Aberdeenshire – Details of what Aberdeen archives hold, as well as background information and suggestions for searching poor law records. There are some indexes listed, including a database held by Aberdeen & North East Scotland Family History Society.
