Kate has been researching family trees for over 30 years and now works as a professional genealogist based in Linlithgow. She has an MSc in Genealogical, Palaeographical and Heraldic Studies from the University of Strathclyde, Glasgow where she is now a tutor on the Family History Research short courses. Kate is an accredited member of the Association of Scottish Genealogists and Researchers in Archives (ASGRA).

In this presentation Kate told the story of how a single entry in a school admission register led to uncovering stories of 3 generations of one family in sources from workhouses, prisons, passenger lists and British Home Children, to name just a few, from Scotland, England, Canada and USA.



Andrew has been working as a professional genealogist since 2015 in the Scottish Borders. He has a postgraduate diploma in Genealogical, Palaeographic and Heraldic Studies from the University of Strathclyde. He has presented on the Records of the Kelso Dispensary and Using Buccleuch Estate records at previous Scottish indexes Conferences. Andrew is accredited on the Register of Qualified Genealogists (RQG).

Andrew's interesting presentation broadened our knowledge of the textile industry and helped us understand why our ancestors may have moved. 

Robbie joined us to represent the National Library of Scotland (NLS) who have a vast amount of material to help us trace our Scottish family history.

The NLS has a [dedicated family history section](#) which will tell you about online and offline records.

Their free 'Digital Gallery' section is well worth a look. From there you can access a variety of records. Some are particularly useful to family history but there are also some general history sections which are very interesting too.

One of the resources which many of us bookmark are the Statistical Accounts of Scotland 1791-1875 which [you can view online here](#).

For those of us who live in Scotland, National Library of Scotland registration gives us free access to an extensive range of [eResources](#). This includes free access to the British Newspaper Archive.



What a gripping story Margaret told! I think we all became quite attached to Sarah who was tried and found guilty of culpable homicide in 1847. You can see Sarah’s [entry in our indexes here](#). Margaret was able to use a variety of sources to tell Sarah’s story from her apprehension to release.

New Releases on Scottish Indexes

We were delighted to announce the release of over 100,000 prison records to www.scottishindexes.com. As with all of our records, the indexes are free to search. They are comprehensive, so even from the index entry you should learn a lot about your ancestor. We already had a large criminal database online which means that 'Scotland's Criminal Database' now contains over 280,000 entries from a variety of sources.

Over the coming weeks, we will be adding more records so keep an eye on our [Facebook page](#) for announcements.

A few weeks ago we released an index to Wigtownshire Poor Relief Records which I am delighted to hear has already helped people to solve some long-standing mysteries! This update also included entries from Castleton Register of the Poor 1846-1864 (Roxburghshire) and Drumelzier Register of the Poor 1845-1864 (Peeblesshire).



Central Scotland Family History Society




